==== **Golf Membership** Golf members are entitled to use the golf, tennis, swimming and dining facilities of the Findlay Country Club. Golf members are not required to pay greens fees or court fees. Golf members enjoy voting privileges and hold stock in the Club. In addition, a refundable \$100.00 Stock Certificate and Annual Bundling fee of \$440.00 will be assessed.

==== **Corporate Golf Membership** Provides a company the option of designating one or more employees to enjoy full golf privileges. The designees may be changed at a cost of \$1,200.00. A designee slot may be left unused for up to six (6) months at no charge. If a vacancy remains six (6) months or more, monthly fees must be paid until a new designee is named, for a maximum of six (6) more months. The membership is forfeited for vacancies longer than 12 months. Designees are subject to standard approval procedures of the Club. The Corporate Golf membership will be entitled to one vote and each designee will pay the current monthly dues. In addition, a refundable \$100.00 Stock Certificate and Annual Bundling fee of \$440.00 will be assessed.

==== **Associate Golf Membership** The Associate Golf classification offers members the ability to play 24, 9-hole golf rounds any day after 1:30 pm and use of the golf practice facilities for the fiscal year (March-February). Members are entitled to use the tennis, swimming and dining facilities but they are not entitled to hold stock, vote, hold office nor hold any property rights in the Club. There are no bundling fees associated with this membership.

==== **Junior Golf Membership** Junior Golf memberships are tailored to the needs of younger families wishing to join the Club. These memberships are open to individuals between the ages of 30 and 35 years old. Members shall enjoy all privileges of a full golf membership. In addition, refundable \$100.00 Stock Certificate and Annual Bundling fee of \$440.00 will be assessed.

==== **Junior Associate Golf Membership** Junior Associate Golf memberships are designed for those individuals or couples between the ages of 18 and 29 years old and are for a period of one year, beginning March 1st and ending February 28th. An annual fee of \$1,500.00 plus tax, payable upon joining, can be paid in two installments of \$750.00 in March and April. After age 29, Junior Associate Golf members would upgrade to Junior Golf as described below.

==== **Clubhouse Membership** Clubhouse members are entitled to use the regular dining services, banquet services, swimming pool and tennis facilities of the Club, including member social functions.

- **All classifications of membership are subject to an annual food & beverage minimum charge** for the period beginning October 1st and ending September 30th. The food & beverage minimum charge is \$1,100.00 per couple and \$650.00 per single. **See above for Junior Associate Golf Membership food & beverage minimum.**
- **Golf, Corporate Golf and Junior Golf Members are subject to an Annual Bundling charge**, which is not included in the monthly fee payment above. One-third of that fee is billed in March, April and May. Bundling charge includes family driving range membership, one bag storage and one locker rental.

Additional Information

NON-RESIDENT GOLF MEMBERS

Non-Resident Golf members shall be limited to no more than ten members, 18 years of age or older who maintain no residence, permanent or temporary, within a 40 mile radius of the Club. They shall have and enjoy all rights and privileges of the Club enjoyed by a Golf member. A Non-Resident Golf member will not be charged the Annual Food and Beverage Minimum, Debt Retirement, Capital Enhancement or Bundling fees.
